HIGHWAY TO HEALING | The Transformation of the West Baltimore I-40 Corridor

THE CHALLENGE

The I-40 corridor, infamously known as 'The Highway to Nowhere', is a physical scar of the historic injustices that have been

endured by the West Baltimore community since the creation and expansion of the U.S. interstate highway system in the midtwentieth century. Families, homes, and entire neighborhoods were removed for an incomplete stretch of highway that was

intended to connect downtown Baltimore to the suburbs in the adjacent counties in reaction to 'white flight'. There have been

numerous attempts made to remove the highway and restore the connections that were lost nearly 70 years ago, however, these

attempts often resulted in unresolved conditions and unmet promises.

In 2023, two pivotal moments in local and national legislation made the vision of necessary restoration and reconciliation in

West Baltimore a reality. First, the city of Baltimore was awarded a \$2 million grant through the Reconnecting Communities Pilot

Program as part of the Infrastructure Investment and Jobs Act to address the Highway to Nowhere and 'undo the wrongs of the

past'. Studies are currently underway through West Baltimore United, a division of the Baltimore City Department of Transportation.

Second, with the election of Governor Wes Moore, the vision of a new east-west transit line was reintroduced, and the hope of

reconnecting Baltimore's communities was restored. The Red Line will be "a high-frequency, high-capacity transit line for the

Baltimore Region, and will be an investment in residents' access to jobs, education, services, and opportunities" (redlinemaryland.

com). A transit stop is currently proposed near the existing West Baltimore MARC station and serves as the location of the project

site (see Appendix 5). Together, these two projects will provide the dynamic change needed to restore the

neighborhoods in the

West Baltimore community.

The "Highway to Healing" is a transit-oriented development (TOD) master plan that will be the epicenter of transportation,

development, and engagement in Harlem Park, Midtown-Edmonson, and the surrounding neighborhoods. Project teams mustpropose a design for a new transit hub that addresses the needs and desires of the immediate community, provides an efficientand effective solution to the addition of the Red Line through the I-40 corridor, and supports future inclusive and responsivedevelopment. Now is the time to exchange ideas as designers; to rebuild and heal the scars that have been left from decades of neglect and economic inequity. A successful proposal will approach this project holistically, acknowledging the past and celebrating a bright and inclusive future.

Each presentation may include, but is not limited to, concept diagrams, plans, sections, elevations, 3D renderings and/ or video not to exceed 1 minute in length, to convey the team's design. The video can include renderings, still images, animation, audio, etc. and must be embedded into the Powerpoint file.
 - Incorrect presentation slide sizes or orientations will be disqualified.
 - Videos that are not embedded into one of the four presentation slides will be disqualified. Hyperlinks copied into the Powerpoint are not acceptable.
 - Revised slides will not be accepted after the deadline.
 - Physically mounted boards will not be accepted.
 - Maximum file size = 40 MB.
